Szentendre

Szentendre is a charming little town on the bank of the Danube river, and it is widely known for its well-preserved historical monuments, religious buildings, galleries and artists. In Ancient Times the area of the town was already inhabited by the Romans, and it was a very important station of the fortified frontier of the Roman Empire, but in the time of the Migration Period the area became totally desolated. After the settlement of the Magyars in Hungary in the X century the town was re-established and became an important cultural and economic centre of the region. After the end of the Ottoman conquest of Hungary the town was rebuilt by the Magyars and the Serbian refugees, who were allowed by the king to settle in the region around Budapest, thus Szentendre turned into the religious, cultural and political centre of the Serbs in Hungary.
